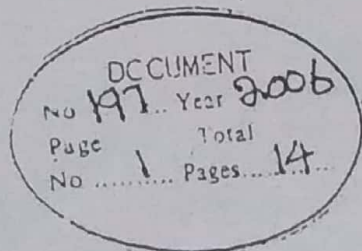

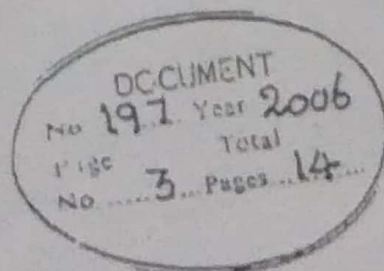

- vii) To provide all facilities like accommodation, books, cloth and all other basic neceities and medical aid to all persons without any discrimination of caste, creed, religion or sex etc., to those who are doing research work.
- viii) To give financial assistance to scholars, teachers, students etc., engaged in the study of Indian culture, Indian philosophy / thoughts etc., to all persons without any discrimination of caste, creed, religion or sex etc.

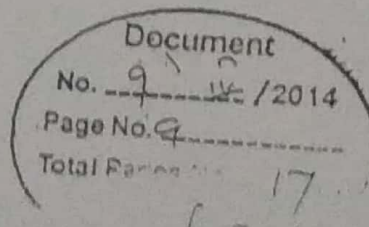

- ix) To undertake maintenance and renovation of ancient, archeological, historical and cultural importance places.
- x) To give financial assistance for marriages of the poor without any discrimination of caste, creed, religion or sex etc.,
- xi) To encourage studies and institute scholarships, prizes, etc., for the students any educational institutions and for students studying a particular subject or course or those undergoing training in particular field or those engaged in research in any field of creative activity in any part of India.
- xii) To publish books, journals, periodicals etc., which helps the fulfillment of the objects of the trust.
- xiii) To do all such other law full things incidental or conducive to the attainment of the above objects.
- xiv) The trust will not do any business / trading activity with the intention of earning profit. And benefits shall be available to the public at large without any discrimination on the grounds of religion, race, caste sex, place of birth or any of them.

5. GENERAL CLAUSE :

- i) Trust shall be a public and shall be irrevocable.
- ii) The Trust shall not alter or amend any basis object clauses except in accordance with law and after obtaining the prior approval of the Director of Income-tax (Exemptions) and such other authorities empowered under the act.
- iii) No activities of the Trust shall be carried out outside India. It shall be strictly carried out within India.
- iv) The income arising to the Trust from its corpus fund and the contributions received by the Trust shall be utilized solely and exclusively for the purposes of carrying out the objects of the Trust and no part of the Income of the Trust or its corpus shall at any time be distributed in any manner among the authors, donors, trustees, contributors or persons defined in sec. 13 (1) of the Income-tax Act, 1961.

- v) In the event of the winding up/dissolution, the net funds/assets remaining as on the day of dissolution shall be transferred to such Trust whose objects are similar to those of this Trust.
- vi) The activities would be of purely Charitable in nature and not motivated for profit.
- vii) The benefits of the Trust shall be available to the public at large without any discrimination on the grounds of religion, race, caste, sex, place of birth or any of them.
- viii) The funds of the Trust would be invested as per sec.11(5) of the Income Tax Act, 1961.
- ix) The Trust funds shall not be applied for any religious purpose or given to any religious institutions except as permissible under the Income Tax Act 1961 from time to time.
- x) To borrow to Funds / Loans / Advances/ from any Bank, Financial institutions from private parties / Individuals or any other Lenders etc., for the purpose / Benefit of the Trust and for the Advancement and expansion of the trust objectives / Activities. All Borrowings / Loans shall be made only for the purpose of the Trust objective / activities and each and every Borrowing shall be made only with prior return approval / consent of all the Trustees.

6 MANAGEMENT OF THE TRUST :

Shri.N.KUMARAN shall be the Chairman and Managing Trustee of the Trust, He shall hold office for his life time. After the demise or relinquishment of office of the Managing Trustee or in the event of the Managing Trustee failing to nominate his successor in office, the board or trustees shall appoint one among them as the Managing Trustee.

In the event of resignation of any trustee / trustees, the remaining trustees shall appoint any suitable person as trustee to manage / conduct the affairs of the trust.

The Number of trustee shall not be less than three and not more than five.
